REPORT

on the work carried out by the "Compliance Control" system management department to fight against corruption at Tashkent State University of Oriental Studies during 6 months of 2021

The control plan for ensuring the implementation of the tasks defined in the "Roadmap" for 2021 regarding the fight against the hidden economy and corruption and its prevention and the following activities were carried out by the department in connection with the implementation of the plan of measures to be implemented at Tashkent State University of Oriental Studies in 2021.

In particular, based on the order of the Rector of TSUOS № 214 dated July 2, 2021, the "Compliance Control System Management Department" was established to fight against corruption. Based on the action plan of the department, preventive activities, and roundtable discussions were held among university employees, professors, and students to prevent and fight against corruption. In particular, in these events, special attention was paid to the content and nature of the approved measures according to General Prosecutor's Office will address the shortcomings specified in the report № 19/10-21-101 dated September 16, 2021 "On elimination of causes and conditions that enable crime".

Monitoring of the work on placement of students in student residences was carried out in cooperation with the Vice-rector for youth issues and spiritual and educational affairs of the university.

He also took part in the activities of the procurement commission established at the university in order to ensure transparency and legality in the field of public procurement and to prevent corrupt situations.

On the basis of the order N_{2} 412 of Minister of Higher and Secondary Special Education of the Republic of Uzbekistan dated September 30, 2021 "On measures to increase the effectiveness of spiritual and educational work in the higher education system", interviews were conducted by the working group in order to implement the recruitment process for the position of tutor at TSUOS based on the principles of openness and transparency and to prevent the commission of corrupt offenses in these processes.

Also, on October 27, 2021, the content and essence of the seminar training on "Fighting corruption and managing conflicts of interest in the Ministry of Higher and Secondary Education of the Republic of Uzbekistan" organized by the Ministry of Higher and Secondary Education is being carried out among faculty staff and students.

In order to prevent conflict of interests and corruption offenses in order and other regulatory documents adopted by the university, the department is constantly monitoring.

At Tashkent State University of Oriental Studies, 8 preventive events, 4 roundtable discussions, 3 seminars, 3 educational events were organized on the topic "Prevention and fight against corruption", 55 professors and 450 students participated in them. Surveys were conducted among 1978 students and the results were discussed.

Also, a hotline, @tsuosanticorruptionbot, has been established by the Department for receiving and reviewing appeals for university professors, employees, and students to report corruption cases.

The following works were done in accordance with paragraph 3 of the comprehensive action plan "Organization of 10 days of "Youth against corruption" in educational institutions" for providing legal education to young people in the field of combating corruption, as set out in paragraph 43 of the State Program on Combating Corruption for 2021-2022 at Tashkent State University of Oriental Studies:

On December 1, employees of University's Anti-Corruption "Compliance Control" system management department and 50 students participated in the Youth Press Club organized by the Youth Affairs Agency in connection with International Anti-Corruption Day on December 9.

On December 3, 2021, a debate tournament was organized among students under the slogan "We are against corruption". In it, the teams debated on the topic "Severe punishments are an important condition for the elimination of corruption".

A photo competition was organized among university faculty staff, and students in order to popularize the hashtag (WE ARE AGAINST CORRUPTION) #BIZKORRUPSYAGAGARSHIMIZ on social networks.

In connection with the International Anti-Corruption Day on December 9, a video contest was organized at the university. Students participated in it with video clips depicting the negative consequences of corruption.

Open classes on the topic "Corruption is an obstacle to our development" were organized by the employees of Department of Management of the "Compliance Control" system of the university to fight against corruption.

On December 10, 2021, a roundtable discussion on the topic "Corruption is an obstacle to our development" was organized. At the event, H.Abdurahmonov, head of the Compliance Control Department of the Ministry of Higher and Secondary Special Education, O. Latipov, head of the Anti-Corruption Agency, and A.Alimov, head of the Youth Affairs Agency, attended the event with their lectures.

No corruption cases were detected in Tashkent State University of Oriental Studies during 6 months of 2021.
